- 2. <u>Eligibility Criteria</u>: The age of retiree/pensioner shall not exceed 62 years on the date of publication of advertisement.
- 3. Pay: A fixed monthly amount shall be admissible, arrived at by deducting the basic pension before commutation from the pay drawn at the time of retirement.
