2. The enhanced rates of monthly allowances will be applicable from the date of issuance of this Notification.

3. All the old awardees prior to 05.06.2009, who could not claim the benefit earlier, will be paid as per the above rates, however, no arrears will be paid to them. The benefits will be paid

from the date of sanction by the Chandigarh Administration. In case of death of awardees, his wife is eligible for claiming the above financial benefits.

4. The cash awardees who are receiving monthly allowances will be required to submit their live certificate to the Deputy Commissioner-cum, Controller Civil Defence, Union Territory, Chandigarh as well as one copy of live certificate to Zila Sainik Welfare Office, Union Territory, Chandigarh in the month of November every year, duly countersigned by a Class-I Gazetted Officer. In the case of non receipt of live certificate the payment of monthly allowances will be stopped. The payment will resume only after receipt of live certificate.

**ONE TIME LUMP SUM GRANT TO THE CASH AWARDEES BETWEEN 05.06.2009 TO DATE OF THIS NOTIFICATION**

**ONE TIME LUMP SUM GRANT TO THE FUTURE CASH AWARDEES FROM THE DATE OF THIS NOTIFICATION**

6. One time lump sum grant to the future cash awardees from the date of issuance of this Notification will be paid as mentioned below. It is notified that these rates shall apply only to the future awardees and the previous cases will not be re-opened:-

7. Those cash awardees who received one time lump sum grant either from 05.06.2009 or after issuance of this Notification will not be entitled to any other financial benefits

8. The allowance will be admissible to the recipient of the award and in case of his death to his widow who is lawfully married by a valid ceremony. The widow will continue to receive the 100% allowance as admissible to her husband. The payment of the allowance will, however be continued to a widow who gets re-married and lives a communal life with the living heirs eligible for family pensions.



9. In case of posthumous award the amount shall be payable in the following order :-

- (a) Widow 35%, Children 35% and remaining to parents. In case the parents are not alive, the 30% share of the parents will be equally divided between widow and children. In case there is no child, the award money will be divided between parents and widow in the ratio of 50:50. In case of minor children, the amount shall be given in form of a Bank Fixed Deposit Receipts (FDR), which shall be payable only to the Child upon his/her gaining maturity. The interest earned on the FDR shall not be withdrawn in favour of the minor child except with the prior approval of the Deputy Commissioner, Chandigarh, who shall ensure that the amount is spent exclusively for the benefit of the minor.
- (b) If Posthumous Gallantry Awardee is bachelor or single, 100% of the award money will be given to parents. In case one parent has expired 100% of the award money will be given to living single parent. In case both the parents have expired, the prize money will be distributed equally among un-married sisters and brothers.

10. The applicants should submit their applications on the prescribed format available with Zila Sainik Welfare Office, UT, Chandigarh in triplicate to Zila Sainik Welfare Office, UT, Chandigarh for grant of Cash Awards, monthly allowance and land / monetary grant in lieu of land or one time lump sum grant to gallantry award winners alongwith the following documents :-

- (a) Application (as applicable).
- (b) Gazette Notification of India notifying the details of award.
- (c) Residence certificate issued by the Sub-Divisional Magistrate, UT Chandigarh in original.
- (d) Affidavit on Rs.20/- Stamp Paper – from First Class Magistrate in original (as applicable).
- (e) Serving certificate (only for serving personnel).
- (f) Ex-serviceman Identity Card issued by Zila Sainik Welfare Office UT Chandigarh, (only for ex-serviceman).
- (g) Widow Identity Card issued by Zila Sainik Welfare Office UT Chandigarh and death certificate of her husband, (in case of widow claimant).


11. Once the Cash Award Claim is passed by Chandigarh Administration, those who are entitled to receive monthly allowances are required to open a Saving Account in State Bank of Bikaner & Jaipur, Sector 17-D Chandigarh and intimate the same to The Deputy Commissioner-cum, Controller Civil Defence, Union Territory, Chandigarh for payment. Those who are entitled to receive one time lump sum cash awards, are not required to open said account.

12. The notifications providing / enhancement in the cash awards, monitory grants, in lieu of land, monthly allowance and one time lump sum grant issued vide No. 4385-HIII(3)-97/13335 dated 06.06.1997, No. 9788-HIII(3)-2001/1780 dated 25.01.2001, No. 3213-HIII(3)-2003/2215 dated 09.02.2004 & No. 11252-HIII(3)-2008/11001 dated 05.06.2009 which are in vogue have been consolidated in this notification.




