The 20th December, 2022

No. 135502-HIII(3)-2022/20111.—The Administrator, Union Territory, Chandigarh, is pleased to revise rates of the Cash Award (one time), Land or Monetary Grant in lieu of Land (one time), Monthly Allowances, as applicable to the Gallantry/Distinguished award winners. The details of cash incentives to the beneficiaries are enumerated in succeeding paragraphs.

2. The enhanced rates of monthly allowances will be applicable from the date of issuance of this Notification to the cash awardees upto 04.06.2009 only. Thereafter, only one time lump sum grants are being paid in accordance with Chandigarh Administration Notification No. 11252-HIII(3)-2008/11001 dated 05.06.2009.

However, the old awardees, who are entitled monthly allowances and could not claim the benefit in time, will be entitled to receive as per the above rates, provided, **NO ARREARS WILL BE PAID**. The benefits will be paid to the cash awardees from the date of sanction of his claim by the Chandigarh Administration. After death of the awardee his wife is eligible to receive benefits of the monthly allowances on the same rates.

ONE TIME LUMP SUM GRANT TO THE CASH AWARDEES FROM 05.06.2009 ONWARDS

4. The cash awards are announced by the Govt of India and published in Gazette Notification of India. Therefore, it is clarified that one-time lump sum grant of cash awards benefits are applicable to the cash awardees from the date of publication of Notification in the Gazette of India. As the rate of one time lump sum grant of cash award benefits are revised from time to time by Chandigarh Administration, hence, the rates of one time lump sum grant of cash awards are applicable to the awardees of the era as applicable. No arrears will be paid subject to revision of rates from time to time.

Terms & Conditions :

5. The future awardees will be entitled only one time lump sum grant and will not be entitled for any other financial benefits. On receipt of cash award claim the benefits will be applicable from the date of sanction by the Chandigarh Administration and no arrears will be paid.

6. In case of death of an awardee, spouse (as per service records) is eligible for monthly allowances as applicable to the cash awardees. The widow of an awardee, who gets re-married and lives a communal life with the living heirs of family pension, will also be eligible for monthly allowances as applicable to the cash awardees.

7. In case of posthumous awardee, the ratio of award will be applicable as under :—

- (i) Widow 35%, Children 35% and remaining to parents. In case the parents are not alive, the 30% share of the parents will be equally divided between widow and children. In case there is no child, the award money will be divided between parents and widow in the ratio of 50:50. In case of minor children, the amount shall be given in form of a Bank Fixed Deposit Receipt (FDR), which shall be payable only to the Child upon his/her gaining maturity. The interest earned on the FDR shall not be withdrawn in favour of the minor child except with the prior approval of the Deputy Commissioner, Chandigarh, who shall ensure that the amount is spent exclusively for the benefit of the minor.
- (ii) If Posthumous Gallantry Awardee is bachelor or single, 100% of the award money will be given to parents. In case one of parent has expired then 100% of the benefits will be applicable to living single parent. In case both the parents have expired, the benefits will be distributed equally among un-married sisters and brothers.

8. The financial benefits is providing to cash award winners by respective States/U.Ts to their permanent residents only. It is not transferable to any other States/U.Ts. The Cash Awardees of Chandigarh, who are receiving monthly allowances and shifted to another States/U.Ts, will entitle to receive allowances regularly. Similarly resident of other States/U.Ts, who are receiving monthly allowances from their respective States/U.Ts and shifted in Chandigarh, are not entitled to claim monthly allowances from Chandigarh Administration.

9. The cash awardees & their widows who are receiving monthly allowance, will be required to submit their live certificate directly to the Deputy Commissioner-cum Controller, Civil Defence, Union Territory, Chandigarh and copy to Zila Sainik Welfare Office, Union Territory, Chandigarh in the month of November every year, duly attested/countersigned by a Class-I Gazetted Officer, If the live certificate is not received by the said office, then entitled monthly allowances will be stopped and the same will be resumed only after receipt of the live certificate.

Claim of Arrears by NOKs :

10. On demise of cash awardees & spouse (both parents) who were receiving monthly allowance, their next of kin (NOK) may claim the arrears till the date of death of last beneficiary. For claiming of the arrears following documents have to be submitted to the DC-cum Controller, Civil Defence Office, Chandigarh through Zila Sainik Welfare Office, Chandigarh :—

- (i) Personal Application.
- (ii) Death Certificate of both parents.
- (iii) Legal Heir Certificate.
- (iv) Succession Certificate.
- (v) NOC from other Legal Heirs.
- (vi) Bank Account Details.

How to Apply :

11. The applicant should submit the documents as per prescribed format available at website www.chandigarhsainikwelfare.org directly to Zila Sainik Welfare Office, U.T, Chandigarh in triplicate. All documents should be attested by the competent authority of respective unit/formation as per details given below :—

- (i) Application for the award (Appendix 'A').
- (ii) Gazette of India Notification.
- (iii) Residence Certificate issued by the SDM, Chandigarh (Appendix 'B').
- (iv) Serving Certificate (only serving personnel) (Appendix 'C').
- (v) Self declaration (Appendix 'D').
- (vi) Bank Account Details (Appendix 'E').
- (vii) Ex-serviceman Identity Card issued by Zila Sainik Welfare Office UT Chandigarh, (only for ex-servicemen).
- (viii) Widow Identity Card issued by Zila Sainik Welfare Office UT Chandigarh and Death Certificate of her husband, (in case of widow claimant).
- (ix) Photocopy of Aadhaar Card & PAN Card.
- (x) Address should be same as residence certificate issued by SDM Chandigarh and address confirmed by respective defence HQs.

Action - Zila Sainik Welfare Office :

12. On receipt of cash award claim the following action will be taken by the Zila Sainik Welfare Office, U.T, Chandigarh :—

- (i) On receipt of cash award claim documents, the Zila Sainik Welfare Officer U.T, Chandigarh will get verification regarding address at the time of commissioning, address at the time of award and present address as per service records held with respective Defence HQs/Records Office. In case of address at the time of commissioning and present address are different then NOC will be obtained from the claimant parental State/U.Ts.
- (ii) Address of claimant should be matched in Application for the award, Residence Certificate issued by the SDM, Chandigarh and same address should be incorporate in verification certificate regarding address issued by respective Defence HQs/Records Office.
- (iii) Zila Sainik Welfare Office, U.T, Chandigarh will securitize the documents of cash award claim and forwarded the same to Deputy Commissioner-cum Controller, Civil Defence Union Territory, Chandigarh alongwith a copy of address verification from respective Defence HQs/Records Office and NOC obtained from parental State/U.Ts (if applicable).

13. It is further clarified that the cash awards benefits are applicable to the particulars individual from the date of publication of Gazette of India Notification. As the rate of cash award benefits are revised from time to time by Chandigarh Administration, hence, the rates of cash awards are applicable to the cash awardees of era as applicable.

14. The old notifications providing the cash awards benefits i.e. monetary grants in lieu of land, monthly allowance and one time lump sum grant issued *vide* Chandigarh Administration Notifications Nos. 11252-HIII(3)-2008/11001, dated 05.06.2009 and 3659-HIII(3)-2013/2776 dated 14.02.2013, which are in vogue, have been consolidated in this notification.

15. The enhanced rates of monthly allowance will be applicable from the date of issuance of this Notification.
